Northwest FL Beaches International Airport resumes operations



According to Parker McClellan, Executive Director of the airport, ECP is back to normal operations during daylight hours ONLY due to the curfew currently in place in Bay County.

American, United, and Delta Airlines have resumed flight operations during daylight hours. Southwest Airlines will resume operations beginning later this week. SheltAir has been operational since Friday and has been handling relief flights in and out of the airport since then.

Taking flight: New terminal coming to Ocala Airport



Groundbreaking for the new \$6.1 million general aviation terminal at the Ocala International Airport will be held October 29th. The city of Ocala will mark the beginning of construction on a new airport terminal with a groundbreaking ceremony in late October.

The new general aviation terminal at the Ocala International Airport, at 1770 SW 60th Ave., will serve as a great first impression to aviators and guests, airport director Matt Grow said in a news release. The \$6.1 million terminal is predicted to take about a year to construct and has an estimated opening date of December 2019.

Plans show the 17,500-square-foot terminal will include office space for Sheltair Aviation, the airport's fixed-base operator, airport administration and future tenants. It also will have a large restaurant with meeting rooms and three car rental service areas.

Funding for the construction of the terminal was made possible through grants from the FDOT and FAA, airport funds, and the City of Ocala's partnership with Sheltair Aviation, the release noted. A prior Star-Banner story about the proposed terminal states that the airport spans 1,500 acres, has a 7,400-foot runway, a \$3 million

tower and 25 private and airport operated hangars. The airport replaced the airstrip that once was located where the Ocala Target store now sits.

Ocala International Airport is owned and operated by the city of Ocala. An Airport Advisory Board is appointed by the Ocala City Council. The airport serves general aviation, corporate aviation and the air cargo industry, and accommodates flight training. General aviation means the airport provides services of a traditional airport except scheduled commercial flights. The airport oversees about 65,000 landings and takeoffs a year, with about 100 large charter planes annually, such as Boeing 727s bringing in horses for sale at the Ocala Breeders' Sales Company across 60th Avenue and Boeing 757s carrying people. That does not include large private jets.

Demands on the airport are expected to increase as more businesses such as FedEx, AutoZone and Chewy Inc. set up distribution centers or manufacturing here.

The groundbreaking ceremony will begin at 10 a.m. October 29th at the airport. It is free and open to the public. Refreshments will be served. To see renderings of the new terminal, click [here](#).

Greater Fort Lauderdale offers three unique airports to the flying public: general aviation North Perry Airport (HWO); Fort Lauderdale Executive Airport (FXE), which serves corporate jets conveniently from just north of the city's downtown; and Fort Lauderdale-Hollywood International Airport (FLL).



A \$2.3-billion expansion program at FLL, the nation's fastest-growing airport, has included lengthening the south runway to 8,000 feet, the addition of a concourse and US Customs Inspection Facility and proposed plans for up to 95 gates and a new intermodal facility.

Carriers ramping up service here include JetBlue Airways, Southwest Airlines, home-grown Spirit Airlines, United Airlines, Allegiant Air, Silver Airways, Air Canada, Alaska Airlines (formerly Virgin Airlines) and Emirates, which offers a daily non-stop flight between Fort Lauderdale

Allegiant refunds tickets for an entire flight at St. Pete-Clearwater Int'l Airport to celebrate its 40-millionth FL passenger

Allegiant has made its name as a low-cost airline, though not for cutting the price of a ticket to zero. Yet that's what the airline did Thursday at St. Pete-Clearwater International Airport for one planeload of lucky travelers. Everyone on Allegiant Flight 856 to Nashville got a refund for their round-trip tickets, seat assignment fees and baggage fees as the company celebrated its 40-millionth Florida passenger.

"Thank you to each of you for helping us to reach this milestone," Allegiant government affairs director Eric Fletcher told the 166 passengers waiting to board Flight 856. "You're the reason we were able to keep growing in the state."

No one looked happier to get the news than Amy Hunt of Plant City. The second-grade Knights Elementary School teacher threw her hands up and head back when she heard the announcement. "Oh my gosh, it was the best news ever. So unexpected," said Hunt, who paid \$275 for her round-trip ticket. "The flights from here are such a great price to start with. It beats anything leaving out of Tampa or Orlando."

And St. Pete-Clearwater airport wasn't the only place where Allegiant made this gesture. It also gave refunds to one flight at each of the other six airports it serves in

Florida: Destin-Fort Walton Beach, Fort Lauderdale, Fort Myers-Punta Gorda, Jacksonville, Orlando-Sanford, and Sarasota-Bradenton.

Allegiant, based in Las Vegas, began Florida service in 2005 with four routes out of Orlando, and a total for that year of 109,000 passengers. It has carried a total of 80 million passengers in its history, and more than half have flown into or out of Florida.

Since 2006, Allegiant has brought more than 12.3 million passengers through the St. Pete-Clearwater airport, where it is the dominant airline, employing 523 people at the airport and serving 55 destinations. Nashville is among the newest.

Student pilot who tried to steal jet from Melbourne airport to be deported to Trinidad *(Source: FloridaToday.com)*

The Florida Institute of Technology senior accused of attempting to steal an American Airlines jet at Orlando Melbourne International Airport will be deported to Trinidad, placed on America's "no-fly" list, and barred from returning to the United States. In a Monday plea deal, Nishal Sankat pleaded guilty to burglary to a conveyance, a third-degree felony. Prosecutors dropped charges of trespassing and grand theft.

The 22-year-old part-time Florida Tech student, who was studying aviation management, was sentenced to 12 days time served at the Brevard County Jail Complex. He must also pay \$909 to cover the cost of the Melbourne Airport Police Department investigation.

"The plea was part of an agreement reached after an extensive investigation by Melbourne Police, Melbourne Airport Police, Joint Terrorism Task Force, and the FBI found Sankat acted alone and was suffering from depression and mental health issues when he boarded the American Airlines jet on September 20, 2018," the State Attorney's Office wrote in a news release. Investigators said Sankat left his red Toyota idling at the passenger terminal about 2 a.m., climbed a perimeter fence, and boarded an American Airlines jet parked on the tarmac outside the STS Mod Center. Two STS Mod Center employees helped airport police apprehend Sankat. Sankat had no prior criminal history. The Federal Aviation Administration is revoking his pilot's license, state attorneys reported.

The September 20 incident triggered an airport security lockdown for hours. Sankat was jailed on a suicide watch. He had petitioned to graduate from Florida Tech in 2019.

Embraer to assemble two new classes of business jets in Melbourne



Embraer, yet again, is enlarging its footprint on the Space Coast. The Brazilian aircraft manufacturer on Sunday said it will begin assembling two new lines of business jets at the

Orlando Melbourne International Airport. The midsize jets are called the Praetor 500 and Praetor 600, which the company says will "introduce unprecedented range into their categories." The name Praetor — pronounced pree ter — was the title of a high official in ancient Rome. Embraer says the Praetor 500 will be the fastest midsize aircraft capable of reaching Europe from the west coast of the U.S. with a single stop. The Praetor 600, the company says, will be the farthest-flying super-midsize business jet, allowing nonstop flights between London and New York.

The Praetor jets are currently under development with two Praetor 600 prototypes in flight tests, as well as one production-conforming aircraft and one production-conforming Praetor 500. The Praetor 600 is expected to be certified and will begin flying in the second quarter of 2019, followed by the Praetor 500 in the third quarter of 2019.

"The Praetors are aircraft, certainly in keeping with their name, leading the way in redefining the characteristics of what a midsize and super-midsize aircraft deliver to the market," said Michael Amalfitano, president and chief executive officer of the Melbourne-headquartered Embraer Executive Jets.

"The introduction of these aircraft support our vision of fascinating our customers and providing them with superior value and the best experience in the industry," he said.

The aircraft was introduced Sunday at Orlando Executive Airport, a day before the opening of the National Business Aviation Association convention at the Orange County Convention Center. More than 25,000 people from 90 countries are expected for the two-day event.

Operation Airdrop sends planes with supplies to people affected by Hurricane Michael

It wasn't Dylan Leoni's first time flying supplies out to stranded residents because of a hurricane. Leoni was 19 years old when he first volunteered to fly into LaBelle, Florida, to bring supplies to those affected by Hurricane Irma with Operation Airdrop, a nonprofit aviation charity based out of Texas that aids with hurricane relief.

On Saturday, he volunteered again. This time, he flew to help those affected by Hurricane Michael. It was rewarding for Leoni, a now 20-year-old Florida State University

exercise physiology junior, to go into the stranded town of LaBelle and hand out supplies to local residents. For this reason, Leoni felt the pull to help people in Apalachicola, Florida. “It was really rewarding to do that and see their reaction,” Leoni said.

On Saturday and Sunday, Operation Airdrop delivered about 27,000 pounds of essential supplies such as nonperishable foods, water, batteries, bug sprays, diapers and toothpaste with more than 50 private planes from the University Air Center, at 4701 NE 40th Terrace, said Trey Thriffiley, a board member of Operation Airdrop.

The nonprofit is still asking for many of those supplies to be donated. Supplies can be taken to the General Aviation Entrance of the Gainesville Regional Airport on Waldo Road. Operation Airdrop will be operating out of the former Silver Airways Hangar, located at 4505 NE 40th Terrace. The goal of the operation was to help those who couldn't receive supplies because of blocked roads from the effects of Michael, Thriffiley said.

Gear up for larger jets at your airport facilities (Source: AviationPros.com)

In the US, general aviation aircraft fly over 24.8 million hours, of which two-thirds are for business purposes. In addition, the industry generates \$219 billion in total economic output, supports 1.1 million total jobs and contributes \$109 billion to the nation's GDP.



These statistics, provided by the General Aviation Aircraft Manufacturer's Association (GAMA), demonstrate the important role that airports play in providing a place for business aircraft to serve critical transportation needs and promote economic opportunity.

As aircraft manufacturers invest millions of dollars and create thousands of jobs in local communities, their activities have a ripple effect throughout the U.S. economy. In fact, \$23.9 billion in new aircraft were

delivered in 2017, representing a 1.3 percent increase in business jet deliveries over the previous year. A major driver of this growth was the introduction of several new aircraft models into service.

As the general aviation aircraft fleet continues to expand worldwide, buyers of private jets who want to fly long distances are welcoming new, larger models. For example, the Boeing Business Jet (BBJ) is approximately 65 percent taller than luxury jets such as the Global Express or Gulfstream V. With a tail height exceeding 40 feet, the BBJ is required by National Fire Protection Association regulations to be housed in a more expansive “Group I” hangar with a more expensive fire suppression system. The aircraft's extra weight also requires thicker concrete in the hangar floor and apron area.

While not as large as the BBJ, other business aircraft recently introduced to the market include the Gulfstream G650 – which spans approximately 100 feet wide, 100 feet long and over 25 feet high – and the Bombardier Global 8000 – which spans over 104 feet wide, 102 feet long and 27 feet high.

NASA celebrates 60 years of space exploration *(Source: FloridaToday.com)*

October 1st marked 60 years since the establishment of the National Aeronautics and Space Administration, or NASA. Sixty years later, Americans have the Kennedy Space Center, we have been to the moon, and we are planning human missions to Mars. Walking down Bob Sieck's hallway at his home in Viera is like going through the history of NASA.

Sieck started just as the space agency was getting started. He began with the Gemini program, tasked with figuring out how to get an astronaut's health vitals in space transmitted back down to Earth. "Today when you go in a hospital and you see a nurse or practitioner watching a dozen patients at a station remotely, you can thank the space program for that," said Sieck.

In the Apollo program, he worked on the spacecraft that would send the first men to the moon. Then he would become one of ten to serve as a space shuttle launch director, giving the final go for launch. "The only number that's important is the number of landings, I'm thankful is the same number of launches," said Sieck.

Sieck has seen the highest highs and lowest lows at the space agency. Now that he has retired, he is concerned NASA is too worried these days about making mistakes. "The probability of launching back when I started, being a spectator, was one in three: You'd either launch, scrub or blow up, really," he recalled. "Nowadays, a test flight has got to go perfectly or it's portrayed as another failure."

However, he believes the men and women at the space agency will be able to take America farther into the stars. "It's optimistic from the standpoint that whatever mission or task they're given, they'll get it down," said Sieck.

Space lovers have to wait a long time for the next big NASA mission. Next year, humans will once again launch from Florida's Space Coast on commercial

rockets, with the aid of NASA.

In addition, the space agency is currently developing the spacecraft and systems that will be able to return humans to the moon in the next decade and to Mars in the 2030s.

President Trump signs 5-year FAA/TSA Reauthorization Bill

A bill to reauthorize the Federal Aviation Administration for five years, including a new airport infrastructure grant program and also an initial \$1.7 billion to help southeastern states recover from Hurricane Florence is now on the books. President Trump signed the measure on October 5th, two days after it won final congressional approval when the Senate passed it on an overwhelming 93-6 vote. The House approved it on September 26th by a strong 398-23 vote.

Besides the FAA authorizations and the post-Florence funds, the legislation also has provisions directing the Federal Emergency Management Agency to put more emphasis on pre-disaster planning, by requiring FEMA to devote part of its overall relief funding to early mitigation work.

It also contains the BUILD Act, which will combine several existing US international development programs into a new US International Development and Finance Corp.

Current FAA authorizations were set to lapse on September 30th. But Trump signed a one-week extension on September 30th, which gave the Senate a bit more time to vote on the five-year FAA measure.

In one of the bill's major construction provisions, it holds authorizations for FAA's core Airport Improvement Program infrastructure grants at their current level of \$3.35 billion per year, through 2023.

But it also has a multi-year authorization for a new airport infrastructure program composed of discretionary grants.

FAA relaunches \$500 ADS-B rebate program

The FAA is relaunching its \$500 ADS-B rebate program, effective immediately through Oct. 11, 2019. The agency is making \$4.9 million available under the rebate program, which will fund 9,792 ADS-B Out installations. As of Jan. 1, 2020, aircraft flying in airspace where a transponder is currently necessary will be required to be equipped with compliant ADS-B Out technology.
