Conrad explained. "Actually, Airborne Express, one of their operators." "And they

said 'can you handle large aircraft here?'" he went on. "And we said, 'we can handle large aircraft here, but we don't have buildings or facilities for you to operate in and out of.'" That's because all of the airport's other facilities were filled with businesses. But the city had already started work on a \$17 million air cargo site in hopes of attracting customers.

When Amazon started getting serious about an air cargo facility in the center of Florida, Lakeland Linder was ready. It simply reconfigured its plans to meet Amazon's needs. "We were able to entice them to be here because we started this work and received the environmental approvals and the green light from the FAA to move forward," said Conrad. Keeping the deal quiet during negotiations was tough. "It was the worst best kept secret in Polk County and the city of Lakeland for quite some time," said Conrad.

Conrad said Amazon was expected to start construction on its facility this summer and it could be open with a thousand jobs in the summer of 2020.

“The new 3-D technology is CT, computed tomography, like a CT scanner you would see in a hospital, but they have been moved over and modified for use in airports,” said Mark Howell, TSA regional spokesperson.

This state-of-the-art technology is changing the way TSA can detect potential threats, allowing agents to get a better look at a bag going through the scanning system. “The new 3-D technology gives the operator the ability to move the image 360 degrees, whereas the machines we are currently using are 2-D. They are doing the job, but everything is on a flat image,” added Howell. The new system will also speed up the process for passengers by letting them keep items in their carry-on bags, like their electronics. “The good thing with these machines, it’s a win-win for both parties. We are going to get better detection capabilities and passengers will see fewer things to take out of their bags,” said Howell.

TPA only has one of the new 3-D computed tomography screening systems. It is located in Airside C Departures. TSA plans to gradually add more of these new systems to TPA and other airports throughout the coming years.



Career opportunities in Aviation: airport tour exposes Navy Jr. ROTC Cadets to the endless possibilities that the industry offers



At BCT, one of our primary objectives is to expose high school students to the numerous career options in the aviation industry. While many students think the only option is to be a pilot or flight attendant, we know that there are a number of positions behind the scenes that are just as necessary.

On Thursday, May 2nd, a select group of Boca Raton High

School students — all of which were Navy JROTC aviation cadets — got to see firsthand many of the opportunities available in aviation.



“They got a chance to learn about the Airport’s history, our role in the community, (and) what we do as Airport staff,” said Scott Kohut, Deputy Director of the Boca Raton Airport Authority. “They’ve been out on the field interacting with the FBOs, the mechanics, the air traffic controllers, the CBP folks; really getting to see what goes on at an airport like Boca Raton and what career options are available.”

[Air purifying company to move manufacturing to Lakeland](#)

A San Francisco air purification company with ties to Lakeland plans to open its first manufacturing facility here. The company, named Molekule, will initially have dozens of employees at a facility on Anchuca Drive west of Lakeland Linder International Airport.

From a blog post written by Dilip Goswami, CEO and co-founder of Molekule, it sounds as if the company plans to grow. "We'll use our new PECO Zero factory to build out our innovation team to create a hub for research, development and manufacturing," Goswami wrote. "With our strong local ties, we're committed to bringing economic growth to the state and expect to create hundreds of job opportunities for Florida residents, which will range from manufacturing to R&D (research and development) for our patented PECO technology and other material science advancements."

Sean Malott, president of Central Florida Development Council, said the company was derived from a program that helped startups at the University of South Florida. From there it grew in Silicon Valley. Its research and development team is already located at USF. The company also has a Lakeland connection. Jaspreet Dhau was an assistant professor of chemistry at Florida Polytechnic University from 2014 to 2018 before moving west. He now leads the company's research and development division.

Initially, Malott said the facility, which will be named Molekule PECO Zero, will have a couple dozen employees. It currently uses contractors to make the purifiers, but now Lakeland will be the central location for the manufacturing of the air purifiers.

According to the company's website, the technology inside the PECO air purifier was developed 20 years ago by solar energy scientist Yogi Goswami, who was attempting to reduce his son's breathing problems. Goswami was attempting to address the growing problem of indoor air pollution inside the home. The air purifier, which sells for \$799, cleans air by combining traditional filtration principles with chemistry, according to the website. The business will receive tax breaks for coming to Lakeland. In 2018, county commissioners voted to give Molekule \$50,000 in incentives. Documents show the company committed to paying an average annual wage of \$46,500.

City officials have estimated that the city's seaplane base and marina, which was destroyed in September 2017 by Hurricane Irma, should be up and ready for use by late fall 2020.

The question came up during a recent city meeting outlining details of the proposed performing arts center when a handful of citizens expressed concerns about the amount of time some city projects are taking to complete — the docks topping the list — and whether a new project would derail the others.

City Administrator John Drury said the dock rebuild is right on track with the approximate four-year timeframe it takes to construct a large city project and, in fact, is on "hyper speed" because it is a re-build.

"How long does it take to build a city project that is large?" Drury wondered aloud during the May 16 meeting. "The rule of thumb in a governmental agency is that it takes one year to decide whether to do the project, it takes one year to find the money, one year to design, engineer and permit a project, and one year to construct a project — and that's a fast-track community project."

"So when are the docks gonna come? Remember I told you four years to build a project, and that the first year we have to decide if we're gonna build it?" Drury said. "Well guess what? The docks were already built so we don't have to spend one year on that. We just skip that, so the good news for the docks is that it's not four years, but three years."

"That project is on hyper speed. Hyper speed," Drury added.

The city is having to rebuild its entire Seaplane Base because it, along with a fueling station, was swept away by the 2017 storm as it made its way through Wootton Park. The storm pulled up walkways and tossed docks and more than two dozen boats. What remained where the docks once stood were empty pilings. The few that were left standing were badly damaged.

Grants boost space projects with Israel

Three Space Florida research grants totaling more than \$750,000 were awarded Monday to partnerships between companies in Florida and Israel as part of Gov. Ron DeSantis' economic-development trip to Israel.

A fourth grant, which would push the amount to just over \$1 million, awaits final approval, said Space Florida President and CEO Frank DiBello during a meeting at the Peres Center for Peace and Innovation in Tel Aviv.

The awards were announced as Space Florida, the state's aerospace-business arm, and the Israel Space Agency signed a memorandum of understanding intended to increase collaboration in scientific programs.

"We're thrilled with the extension of this program because it's been highly successful, but more so to the possibility of bringing an additional range of technologies that can benefit both countries," DiBello said.

The grants included \$250,000 for the Harris Corp. and Nano Dimension Israel to develop 3D printing materials that can survive in the harshness of space, a proposal expected to lower the manufacturing cost of small-satellites; \$265,000 grant for Cadw Therapeutics LLC, The Moffitt Cancer Center and Research Institute and SpacePharma R&D Israel to test human stress and the impact of space on human DNA; \$250,000 for Semplastics EHC LLC of Oviedo, and Polymertal LTD Israel to develop "a novel class of hybrid materials, suitable for aviation, and space applications, ranging from structural parts to electronic assemblies."

DiBello said a fourth award, pending final approval, is to go to a partnership between Lockheed Martin Space Systems and StemRad, Ltd. Israel to complete development of AstroRad, a wearable astronaut radiation shield. The radiation shield is scheduled to be sent to the International Space Station in July for testing. The grant is worth \$250,000.

All four grants were among 12 finalists approved by the Space Florida Board of Directors on May 15.



By the numbers: Florida finishes 13th on best state ranking

Florida was ranked the 13th best state in the nation, based on criteria such as health care, public education and economic growth, according to a new analysis by U.S. News.

The ranking included more than 70 metrics aimed at measuring how well states are working on behalf of their residents, according to U.S. News. Weighted most heavily in the analysis was health care quality, access and affordability, followed by the performance of their K-12 schools and higher education systems.

Florida ranked 29th among the states on health care, third on education, ninth on its economy and 14th on infrastructure. Criteria measured by the study included unemployment rates and gross domestic product growth; the condition of roads, bridges, electricity grids and transit options; and air and water quality.

FAA implements changes for recreational UAS operations near airports

The FAA yesterday announced details on how the agency is implementing the new rules governing hobbyist and recreational drone users that were part of the FAA reauthorization law that Congress approved last year.



In a statement, the FAA indicated that recreational users are now required to obtain an FAA authorization before flying in controlled airspace near airports. This replaces the existing practice where those users would notify the airport operator prior to operating within five miles of the airport. The full FAA notice is scheduled to be published in the Federal Register today.

Prior to congressional passage of the FAA reauthorization in 2018, hobbyist and recreational drone users were required to comply with what was known as the Special Rule for Model Aircraft if they were not FAA-certified remote pilots. This special rule included a requirement for the user to notify the airport and, if applicable, the air traffic control tower if the user intended to fly their drone within five miles of an airport. Airports have offered a number of methods to facilitate this notification requirement since the process was implemented in 2012.

FAA makes LAANC available at more than 100 contract tower airports

The FAA has announced that the Low Altitude Authorization and Notification Capability (LAANC) service is now available at 109 airports with contract towers. LAANC allows certified remote pilots to obtain near real-time airspace authorizations if the pilot intends to fly a small UAS below pre-approved altitudes near an airport in controlled airspace.

Without LAANC, pilots are forced to obtain the necessary authorization through a slower FAA process which can take up to 90 days. The announcement means LAANC is now available at about 400 air traffic facilities covering nearly 600 airports.

AAAE has been urging FAA to make the LAANC service available at contract tower airports. Prior to the FAA announcement, LAANC was not available at any of these airports. Moving forward, AAAE is urging FAA to include all airports with contract towers in the LAANC program.

Hemp products and CBD meds cleared for takeoff

Food and Drug Administration-approved hemp products like certain CBD medications are now allowed in both carry-on and checked bags.

In an update to its website's "What Can I Bring?" section, the Travel Security Administration clarified that Food and Drug Administration-approved hemp products like certain CBD medications are now allowed in both carry-on and checked bags.

In the past, TSA did not differentiate between marijuana and other hemp derivatives and warned that cannabis products wouldn't be allowed in carry-on bags or checked luggage.

In December the \$867 billion federal Farm Bill, among other things, classified hemp as an agricultural commodity and took it off the federal controlled substances list. Hemp, a form of the cannabis plant, contains only trace amounts of THC — the naturally occurring component in marijuana that produces a high. Cannabinoid oil, or CBD, can be extracted and processed from the hemp plant to be used for medicinal purposes.

Even though the FDA has approved certain hemp and CBD products, the sale of those products was not legal in Florida until the state passed a bill to authorize a state hemp program this spring. The governor has not yet signed the bill into law.

Possession of marijuana and some other cannabis products is still illegal under federal law, and TSA officers will still be required to report any suspected possession violations, a TSA spokeswoman said. If any illegal substances are found during the routine security screening, the TSA refers the matter to local law enforcement.

TSA confirmed that its officers were being briefed on the change, which came about after the FDA approved a cannabis-derived seizure medication called Epidiolex.

"TSA was made aware of an FDA-approved drug that contains CBD oil for children who experience seizures from pediatric epilepsy," the TSA spokeswoman wrote in an email. "To avoid confusion as to whether families can travel with this drug, TSA immediately updated TSA.gov once we became aware of the issue."

Some local airports said the rule change would not change the way they operate, while others were not aware any policies were altered at all.

Tampa International Airport spokeswoman Emily Nipps said since the rule change only applies to TSA operations, it will not "affect or change our airport operations," she wrote in an email. The airport will continue to follow state law, which maintains that medical marijuana cannot be consumed on public transportation, in a public place or on an aircraft, she said.

"We continue to follow state laws regarding medical marijuana and CBD products," she wrote.

Miami-Dade Aviation Department spokesman Greg Chin wrote in an email the department was not yet aware of any briefing or updated rule until a reporter called.


