## From the Governor's Office

Florida Governor Ron DeSantis [Executive Order 20-80](#): All passengers arriving from the northeastern United States (New York, New Jersey, and Connecticut) are required to self-quarantine for 14 days from the time of entry into Florida or the duration of the individual's presence in Florida, whichever is shorter, to help prevent the spread of COVID-19 per the Florida Governor's Executive Order issued in late March 2020. Florida Department of Health representatives will however no longer screen arriving passengers with a questionnaire and collect contact information effective June 30, but travelers are still required to self-quarantine upon arrival in Florida. (Updated: July 1, 2020)

## FDOT Airport Information - Follow-Up

Please find the following information as follow-up to FDOT's previous email to assist you in the implementation of Executive Order 20-80 and 20-91. In order to facilitate the collection of Florida Department of Health forms, once the airport has more than 30 survey forms, the airport should contact the appropriate FDOT point of contact identified below for pick up. As stated previously, we encourage you to coordinate with your local health department for direction on implementing the health screening forms and traveler cards.

Pursuant to the U.S. Department of Homeland Security, ADVISORY MEMORANDUM ON IDENTIFICATION OF ESSENTIAL CRITICAL INFRASTRUCTURE WORKERS DURING COVID-19 RESPONSE (attached) as adopted in Executive Order 20-91 (attached), Flight Instruction is an essential function under Transportation and Logistics, page ten (10):

- Employees who repair and maintain vehicles, aircraft, rail equipment, marine vessels, bicycles, and the equipment and infrastructure that enables operations that encompass movement of cargo and passengers.
- Air transportation employees, including air traffic controllers and maintenance personnel, ramp workers, aviation and aerospace safety, security, and operations personnel and accident investigations.
- Workers who support the operation, distribution, maintenance, and sanitation, of air transportation for cargo and passengers, including flight crews, maintenance, airport operations, those responsible for cleaning and disinfection, and other on- and off- airport facilities workers.

## FAA and ADO Updates

### CARES Act Summary

The "[Coronavirus Aid, Relief, and Economic Security Act](#)" (the CARES Act) was signed into law on March 27, 2020, following approval earlier in the day by the US House of Representatives and a unanimous 96-0 vote by the US Senate on March 25<sup>th</sup>. The CARES Act's estimated \$2+ trillion price tag includes: extraordinary public health spending to confront the COVID-19 pandemic; immediate cash relief for individual citizens; a broad lending program for small business; and, targeted relief for hard-hit industries.

As a reminder, there is \$10 billion from the federal general fund to remain available until expended for airports to prevent, prepare for, and respond to coronavirus. The funds provided may not be used for any purpose not directly related to the airport. [CLICK HERE](#) to continue reading.
